

ANDREW PELLER LIMITED ANNOUNCES THE FINAL 2019 ANNUAL MEETING VOTING RESULTS

Grimsby, ON - September 23, 2019 - Andrew Peller Limited ADW.A/ADW.B (“APL” or the “Company”) announced the final voting results from its 2019 annual meeting (the “Meeting”) of shareholders held on September 11, 2019.

The total number of Class B Voting Shares represented by shareholders present in person or by proxy at the Meeting was 35, representing 82.3% of the 8,198,994 voting shares issued and outstanding as of the record date.
